RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I/We \_\_\_\_\_, in consideration of services which have been or will be performed by the SSS Ski Club, Inc. in providing travel arrangements and activities and of being permitted to participate in Club trips, activities, events and other functions which I/we recognize are hazardous, do for myself, my personal representatives, heirs and next of kin:

- (1) Hereby release, waive, discharge and covenant not to sue or hold liable the Sun, Snow and Surf Ski Club, Inc., its officers, its Board of Governors, and their agents and members, jointly and severally, all for the purposes herein referred to as RELEASEES, from all liability to myself, my personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or demands, therefore, on account of injury to the person or property, or resulting in death, whether caused by the negligence of RELEASEES or otherwise while participating in any event or activity;
- (2) Hereby agree to indemnify and save and hold harmless the RELEASEES from any loss, liability, damage, or cost they may incur due to my presence and/or participation during any activity and whether caused by the negligence of the RELEASEES or otherwise; and
- (3) Hereby assume full responsibility for risk of bodily damage, death or property damage due to negligence of RELEASEES or otherwise while traveling, participating or for any other purpose while engaged in such activities.

I/We expressly agree that the foregoing RELEASE, WAIVER, AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the laws of the state, states or countries in which the activity is conducted and that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall continue in full legal force and effect. I/We have read and voluntarily signed the RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, which shall remain in full legal force and effect until such time that I/we notify the SSS Ski Club, Inc. in writing that this agreement is voided and such notification is acknowledged by the SSS Ski Club, Inc.
